Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Goal: Expand the supply of assisted housing

- Utilized an online briefing presentation to help get more applicants on the program.
- Utilized HUD Waivers to increase leasing of new voucher holders through oral verifications and online briefing presentations.
- Expanded our jurisdiction within Westchester County to expand housing options for voucher holders.

Goal: Improve the quality of assisted housing

- Conducted file audits to maintain quality control.
- Continue to conduct Move-Out Inspections and Quality Control Inspections to ensure the safety of the tenant and to assist the Owners in their own quality control of the units.
- Continue to maintain our "High Performer Status" on HUD SEMAP
- Increased our customer service through purchasing Self-Service Kiosks to assist tenants and landlords to get forms off the City of Peekskill Website. Working on improving the kiosks to take credit/debit card payments and cash payments for clients who are on repayment agreements and for landlords who are coming to the City to pay water bills or tax bills.
- Implemented an Electronic File Management Software to have our files go paperless.

Goal: Increase assisted housing choices

- Continue our outreach efforts to get potential landlords on the program through phone meetings and Zoom meetings.
- Gained 40 new landlords on the program through our outreach efforts from 2020 to 2021.
- On a continuous basis we refer participants who are ready for home ownership to housing agencies that have a Section 8 Home Ownership Program. We have been successful with one client who is closing on a home in White Plains.

Goal: Preserve low-income housing for the long-term

- Worked more with outside agencies to help clients with resources during the pandemic.
- Informed landlords of the Eviction Moratorium and encouraged them to have their tenants report any income changes to our agency.
- Sent out information in regards to the Emergency Rental Assistance Program to landlords and tenants.
- Continue to ensure rents for units are fair and within rent reasonableness.
- Worked on reducing non-compliance participants in the HCV Program through effective communication.
- Prosecute non-compliance cases when necessary and continue to demand repayment of federal subsidy when appropriate.

Goal: Promote self-sufficiency and asset development of assisted households.

- Encouraged participants to apply for the City of Peekskill job postings by referring them to our Personnel Department on the City's website to view job postings.
- Conducted zero income briefings on a monthly basis to ensure participants were actively seeking financial means to support themselves through employment.
