**SUMMARY STATEMENT**

THE WESTCHESTER COUNTY DEPARTMENT OF SENIOR PROGRAMS AND SERVICES HAS OFFERED FUNDING TO THE CITY OF PEEKSKILL NUTRITION PROGRAM UNDER TITLE IIIB OF THE OLDER AMERICANS ACT OF 1965 SENIOR SUPPORTIVE SERVICES PROGRAM. THIS FUNDING WILL BE USED TO SUPPORT THE PEEKSKILL NUTRITION PROGRAM TRANSPORTATION OF SENIOR CITIZENS IN THE CITY OF PEEKSKILL TO AND FROM THE NUTRITION PROGRAM.

**RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE WESTCHESTER COUNTY DEPARTMENT OF SENIOR PROGRAMS AND SERVICES TO RECEIVE FUNDING UNDER TITLE IIIB OF THE OLDER AMERICANS ACT OF 1965 FOR THE YEAR 2018 TO ENABLE THE NUTRITION PROGRAM TO PROVIDE TRANSPORTATION FOR SENIOR CITIZENS IN THE CITY OF PEEKSKILL TO AND FROM THE NUTRITION PROGRAM.**

**WHEREAS**, the Westchester County Department of Senior Programs and Services has informed the City of Peekskill that they have approved a budget of \$3,519.00 for funding under the Title IIIB of the Older Americans Act of 1965 for Senior Citizens Supportive Services; and

**WHEREAS**, the funds are intended to provide transportation for the Senior Citizens in the City of Peekskill; and

**WHEREAS**, the City of Peekskill has participated in this program in the past and wishes to continue to do so, and

**WHEREAS**, the City of Peekskill will receive \$3,519.00 in funding from Westchester County; and

**WHEREAS**, the City of Peekskill has allocated the sum of \$2,445.00 as the required matching share as a condition of receiving this funding, and

**WHEREAS**, the matching funds are available through the provision of in-kind services and Budget Line 01-8989, and

**NOW, THEREFORE, BE IT**

**RESOLVED**, that the City Manager, or his authorized designee, is hereby authorized to enter into an agreement with the Westchester County Department of Senior Programs and Services for funding of this program pursuant to Title IIIB of the Older Americans Act of 1965, for the program year of January 1, 2018 through December 31, 2018; and be it further

**RESOLVED**, the agreement shall be in a form substantially similar to the attached hereto, subject to the review and approval of the City Manager and Corporation Counsel; and be it further

**RESOLVED**, that the City Manager or his designee is hereby authorized to take all steps necessary to effectuate the intent of this Resolution; and be it further

**RESOLVED**, that this Resolution take effect immediately.
