**SUMMARY STATEMENT**

THE COUNTY OF WESTCHESTER, ACTING ON BEHALF OF THE WESTCHESTER/PUTNAM LOCAL WORKFORCE DEVELOPMENT BOARD, IS SOLICITING PROPOSALS FROM PUBLIC AND PRIVATE NOT-FOR-PROFIT ORGANIZATIONS TO OPERATE TEMPORARY ASSISTANCE TO NEEDY FAMILIES ("TANF") SUMMER YOUTH EMPLOYMENT PROGRAMS. THE TANF SUMMER YOUTH EMPLOYMENT PROGRAM TARGETS YOUTH 14 TO 20 YEARS OLD. THIS RESOLUTION AUTHORIZES THE CITY OF PEEKSKILL YOUTH BUREAU TO SUBMIT A PROPOSAL/GRANT APPLICATION FOR THIS OPPORTUNITY. FURTHERMORE, THE CITY OF PEEKSKILL AUTHORIZES ACCEPTANCE OF THE FUNDS SHOULD THE CITY OF PEEKSKILL YOUTH BUREAU BE AWARDED A GRANT.

**RESOLUTION OF THE COMMON COUNCIL AUTHORIZING THE CITY OF  
PEEKSKILL YOUTH BUREAU TO SUBMIT A PROPOSAL/GRANT  
APPLICATION TO THE COUNTY OF WESTCHESTER, ACTING ON BEHALF  
OF THE WESTCHESTER/PUTNAM LOCAL WORKFORCE DEVELOPMENT  
BOARD FOR THE TANF PROGRAM**

**WHEREAS**, the City of Peekskill Youth Bureau was created to provide children, youth, and families with effective youth development programs along with assisting City youth in becoming competent leaders with skills that will make them self-sufficient; and

**WHEREAS**, the City of Peekskill Youth Bureau wishes to pursue \$85,000 in grant funding from the County of Westchester, acting on behalf of the Westchester/Putnam Local Workforce Development Board, to operate the Temporary Assistance to Needy Families (“TANF”) Summer Youth Employment Program, and

**WHEREAS**, participants in this program will be engaged in program activities and employment services approximately 20-35 hours per week in worksites that include not-for-profit agencies and government facilities, as well as private sector businesses;

**NOW THEREFORE, BE IT**

**RESOLVED**, that the Common Council authorizes the City of Peekskill Youth Bureau to submit a grant application to the County of Westchester, acting on behalf of the Westchester/Putnam Local Workforce Development Board, for \$85,000 in grant funds to operate the TANF Summer Youth Employment Program; and be it further

**RESOLVED**, if awarded this grant, this Common Council authorizes the City of Peekskill Youth Bureau to accept these funds; and be it further

**RESOLVED**, that the Common Council hereby authorize the City Manager or his authorized designee to take all and any necessary steps to effectuate the intent of this Resolution; and be it further

**RESOLVED**, that this Resolution take effect immediately.
