Replacement of Water Pumps for Hollowbrook

Sealed Bids will be received in the Office of the City Clerk of the City of Peekskill, New York, until 12:00 noon, **Tuesday, May 15, 2018** at City Hall, 840 Main Street, Peekskill, New York 10566, and immediately thereafter the bids will be publicly opened and read aloud in said office. No proposals will be accepted after said time and date.

The work for Contract 2018-001 consists of rehabilitating (replacing the existing raw water pumps, controls, electrical, piping, valving, and installation on new fittings) as shows on the contract drawings.

This entire project is to be funded through this CDBG; no City funding has been budgeted. The selected contractor will be in contract with the City of Peekskill, and under all federal and state CDBG regulations. The city encourages Section 3 and M/WBE firms to apply.

A compact disk (CD) of Plans, Specifications and Contract Documents may be obtained as of **Monday, April 23, 2018** from 9:00 am until 5:00pm at the Department of City Services, Bureau of Public Works, City Hall, 840 Main Street, Peekskill, NY 10566, upon payment of \$10.00 for each CD. This is a non-refundable fee. No paper copies will be distributed.

A pre-bid meeting will be held on **Thursday, May 3, 2018** at 10:00 a.m. in the first floor conference room in City Hall. The meeting is not mandatory, but prospective bidders are urged to attend.

Proposal forms must be copied from the CD. Bids must be made on the proposal forms furnished with the Specifications. As bid security, each proposal must be accompanied by a certified check or a bid bond acceptable to the City in the amount of not less than 5% of the total amount of the Bid. Certified Checks shall be made payable to the City of Peekskill and are to be held by the City as a guarantee for the proper execution and delivery of the Contract and bonds to secure the faithful performance thereof. In default of such execution and delivery of Contract and Bonds, the amount of the deposit represented by the check or bid bond shall be forfeited and retained by the City of Peekskill as liquidated damages.

Proposal forms as specified on the NOTICE in the contract documents must be enclosed in a sealed envelope bearing the name and address of the Bidder, addressed to the City Clerk, City of Peekskill, NY and endorsed Hollowbrook Water Pumps, City of Peekskill, NY, Contract Number 2018-001. All addendums, if any, will be on the City's web page and emailed to all those who purchased the CD of the Bid.

The City of Peekskill reserves the right to accept or reject any or all Bids, or portions of a Bid, to waive any informality in any Bid, and to award the Contract to other than the lowest Bidder if deemed in the best interest of the City of Peekskill to do so.
